FINANCE

- Secretary Treasurer Burdock presented the expenditure report to April 30, 2024
 - Represents 10 months of fiscal year and 8 months of school year, and is first expenditure report showing amended budget passed in February
 - Salaries and benefits for 10- and 12-month employees tracking well, but may need small reclassification between PVP and management
 - Trustee salaries do not include the July 1, 2023 increase, which will result in a \$6,500 overspend
 - Substitute costs tracking high, expecting overspend
 - A change in providers for Extended Health and Dental for CUPE may result in reduction of premium costs, but other benefit costs tracking as expected
 - Supplies and services tracking as expected

OPERATIONS

- Secretary Treasurer Burdock presented the Annual Facilities Grant (AFG) Spending Plan
 - \circ Director of Operations David Reid reviewed the spending plan in detail at the finance meeting on May 14 $^{\text{th}}$
 - o Projects to highlight include:
 - Irrigation installation at Hutton
 - Asbestos management upgrade
 - Exterior upgrades at GFSS
 - Accessibility upgrades
- Superintendent Lautard presented the Long-Range Facilities Plan feedback

 Next step will be to send final survey to each school community based on capital plans for that site only. Goal is to present final draft LRFP to Board in September 2024.
