2. Strategic Plan Update

- Superintendent Lautard introduced the strategic plan update and invited student trustees to share their updates.
 - Cerys Hoover, Kenna MacGregor, and Ashton Finstad provided an update for GFSS.
 Student council is just getting started, with goal to improve student engagement and school culture. Current school clubs/groups include: announcement crew, drama production, global citizenship, e-sports teams, mountain biking, sexual orientation and gender identify, and many sports teams.
 - Elizabeth Tsigonias, Tara Faminoff, and Adaline Molloy provided an update for BCSS. Highlights include grad class fundraising, field trip to Selkirk in Castlegar, hot lunch program, senior musical theatre production, students attending Kiwanis music festival in Penticton, youth advisory council, career 10 class investigating vending machines, spirit club activities such as costume contest and turkey hunt.
- Superintendent Lautard confirmed the Board will be presented with Student Learning Survey data at education meeting in early November.

3. Accessibility Report

- Lois Ehman District Principal of Student Services presented the recommendations from the Accessibility Committee.
 - Committee was established last Fall. Surveys went to staff/families shortly after, and then results reviewed by Committee and categorized. Feedback from reporting tool also collected and recommendations summarized for the Board.
 - Key themes include: lights/sounds/flickering/noise/HVAC, increasing of services, accessible furniture and washrooms, improvement to outdoor spaces and additional training for staff.
